**OLD BUSINESS:** Almendinger reported that we have cancelled the one app on the website for notifications  
and we are exploring other apps that may be more suited to our needs.

**BSTG FIRE  
DEPARTMENT:** Fisher reported that in February there were 127 calls of which 21 were in Trenton. They  
have an affiliation agreement for training hours. They are taking the utility in to M. H. Eby  
for repair. A house on Carters Corner was scheduled to be burned down, but they could  
not because of the asbestos in the building. Fisher stated that the ground breaking was  
really nice.

Justice said that Delaware County Engineer's office wants to work a deal with Trenton to stage their salt and gravel piles at our location. There are usually 2 crew leaders that work out of Hartford Road near Conservation Club. A formal agreement may include widening of our area, repaving our parking lot, building a salt shed and stocking gravel. This agreement would benefit Delaware County by them not having to pay rent for the land that they are currently using and also would give us extra eyes on the property in the rear.

Ron VanWinkle wanted to thank Keith Barney and Kevin Justice for coming to repair culvert on Trenton Road. It was a nasty day, but they were there doing their job.
