\$240,000.

Doug also said that next month they will have paperwork for Trustees to sign regarding the Stockwell Road project. It is estimated to be \$968,000 for the whole project with

contingencies.

Almendinger asked Doug about the AEP pad that is very close to the road on south 605. A representative from the Delaware County Health Department to explain a few offerings of the Health District: 4 weeks of walks of 55 and older, breastfeeding classes thru October, be aware of ticks this year, and there is a complaint form that you can use.

Also the DCHD has their 2024 annual report on their website.

Mr. Wasson asked how many people signed up on website and Almendinger said he thought about 30. Mr. Wasson asked about whether we would be on Facebook and Almendinger said no. Mr. Wasson asked if we were contacted by the State of Ohio and Trustees replied no. He had no dispute about the bike path and will agree that it is Park Preservation's responsibility. Mr. Wasson said he had some food for thought that we as a township could sponsor a walk/run on the trail and possibly call it the Trenton Twp Trot. George Burger asked about car on Creek Road that was parked. Justice said a man

was measuring poles.
