consider the adoption of a Resolution to request the Ohio Department of Transportation to lower the speed limit for Stockwell Road (TR 50) between Township Line and Creek Road (TR53); and

WHEREAS, Stockwell Road (TR50) between Township Line and Creek Road (TR53) is currently 55 mph; and

WHEREAS, in order to provide a consistent speed limit to the traveling public, it has been determined that the Ohio Department of Transportation will consider a 45 mph speed limit for that portion of the roadway; and
