**PUBLIC
PARTICIPATION:** BSTG Chief Kovach and Fiscal Officer Greg Roy attended the meeting. They gave a

Parkway and other implications for growth.

exempt from our Zoning because they are considered another political subdivision.

**BSTG FIRE
DEPARTMENT:** Fisher reported that in August there were a total of 146 calls with 25 of them being in
Trenton Township. There was a volunteer resignation because they found a firefighter
position elsewhere. There is an Open House from 12-2 p.m. on October 26. The new
station should be finished in March. Almendinger asked about the definition of Misc on
run report. Fisher will ask. The new Station is Station #352 and Medic #9 to move to
the same building.

**ZONING
INSPECTOR
REPORT:** Dattilo reported that he had attended the DRPC, Trenton, and BZC meetings last month.
Steve Smith of County Road 605 stated that Sheila Michaels was attacked by one of the
dogs at the house on 605 but was too scared to reported because of retribution.
The homeowner of the cars that are on the edge of road at N. Old 3C and Condit Road
did not respond to certified so Dattilo sent it regular mail. He was able to contact owner
and they are going to sell the cars.

WHEREAS, National Opioid Legal Counsel ("Counsel"), who represents the Township in the Litigation, has informed the Board that a proposed settlement of the Litigation has been reached ("Settlement"); and,
