BSTG FIRE DEPARTMENT: Fisher reported that in October there were 106 runs with 16 of them in Trenton Township. A part-timer resigned to join Marion Township. Conditional offers were given to 6 FF that building. One architect has been disqualified. The department is still working with County to see what percentage of the building they will fund. The new rescue came in. There will be a new swearing in for a Lt. at the Christmas party on Friday night. The bond to be put on the levy will probably be around 8.3 mils for 15 years

ZONING INSPECTOR REPORT: Dattilo reported having attended the DRPC, Trustees and Comprehensive Planning meetings. Hoover reported that there is someone living in a camper in the barn. Dattilo will check it out. There is a new CAD on Longshore Road. There is a meeting on Dec 18 for the Weaver rezone on Murphy Road next to Rattlesnake Ridge. Almendinger reported that the Comprehensive Planning Committee identified properties that may be developed in township. Township may need to consider offering subdivision enticements. The properties recently annexed are a Type II which basically means they are in the Sunbury City but the township keeps the rights to the land taxes and Sunbury will get the zoning fees and income taxes.
